# STREETS, SIDEWALKS AND PUBLIC PLACES

**Statutory Bonds:**

- When reconstruction or construction of a sidewalk is required to be done by contract, the City Manager may require the contractor to give a bond for all contracts exceeding \$10,000.

**Snow and Ice Removal:**

- It is the duty of the owner and of the occupant of any lot or lots abutting upon any sidewalk in the city to remove or cause to be removed from any sidewalk the accumulation of snow ice or other obstructions caused by weather.
